About the RIPE NCC



- Secretariat for the RIPE community
- Maintains the RIPE Database
- One of the five Regional Internet Registries (RIRs)
 - Serving Europe, the Middle East and parts of Central Asia
 - 76 countries
- Allocate and assign IPv4 and IPv6 addresses and also assign AS Numbers
- Outreach, tools, measurements, training and more!

About the RIPE NCC

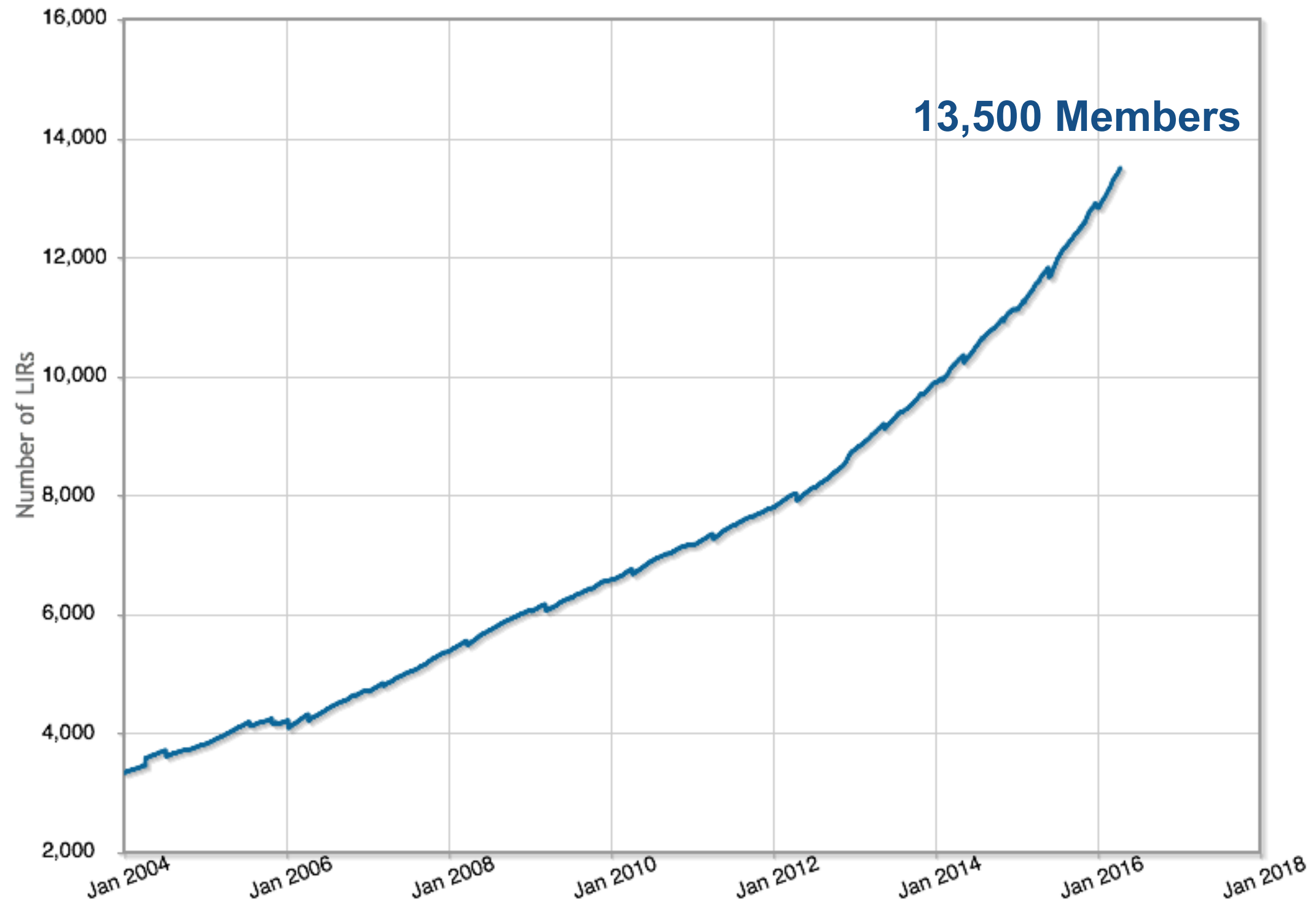


- Independent, not-for-profit, bottom-up membership organisation
- Anyone can become a member
- Incorporated in the Netherlands, governed by Dutch law
- Funded by members, fully autonomous
- Open, transparent, neutral and impartial
- Headquarters in Amsterdam
 - Office in Dubai, staff in Moscow
 - Around 140 staff members

Focus in 2016



- Maintaining a strong registry
- Effective outreach and external relations throughout our service region
 - Regional meetings, member lunches, training etc.
- Improving our entire service offering
- Improving our processes for greater efficiency
- Focus on collecting and acting on member feedback

RIPE NCC Regional Presence



- More focus on RIPE NCC Regional Meetings and community events
- Supporting NOGs throughout our service region
- Engaging with governments in the region, particularly on issues concerning regulation, industry trends and Internet development

IPv6 Status



- Over 70% of our members have IPv6 address space
- Providing technical, hands-on IPv6 training courses
- Improving our online IPv6 training and webinars
- IPv6 Roadshows - currently in MENOG region, expansion into ENOG region planned for 2016

IPv4 Status



- We still have IPv4 addresses left - more than one /8 in the available pool
- Every member can get 1,024 addresses (/22)
- Block reserved for Internet Exchange Points
- Number of transfers increasing:
 - 2,701 IPv4 transfers in 2015
 - Inter-RIR policy implemented in September 2015
 - “Multiple LIRs” discussion monitored by the RIPE NCC Executive Board

Addressing Multiple LIRs



- Since reaching the last /8, some people have started opening multiple LIRs to get additional /22s
- At RIPE 71, our Executive Board put a hold on the ability for a single legal entity to open multiple LIRs
- Membership discussed the issue on the members-discuss mailing list
- Executive Board will propose solutions to the membership, to be voted on at the GM in May

Address Hijacking



- Increased hijacking activity since IPv4 depletion reached
- 134 cases investigated in 2015
- Mostly targeting legacy and Provider Independent (PI) resources
- Sophisticated methods: re-registering expired domains, forged documents
- We urge our members to update their registry data to protect their resources

Improving Members' Registry Data



- Assisted Registry Check (ARC) started in 2014
- A lightweight check of members' registry data conducted over the phone, with emails to follow-up
- Emphasis on adding value by helping members resolve issues, explaining policies
- A replacement of our previous audit activity

RIPE Atlas

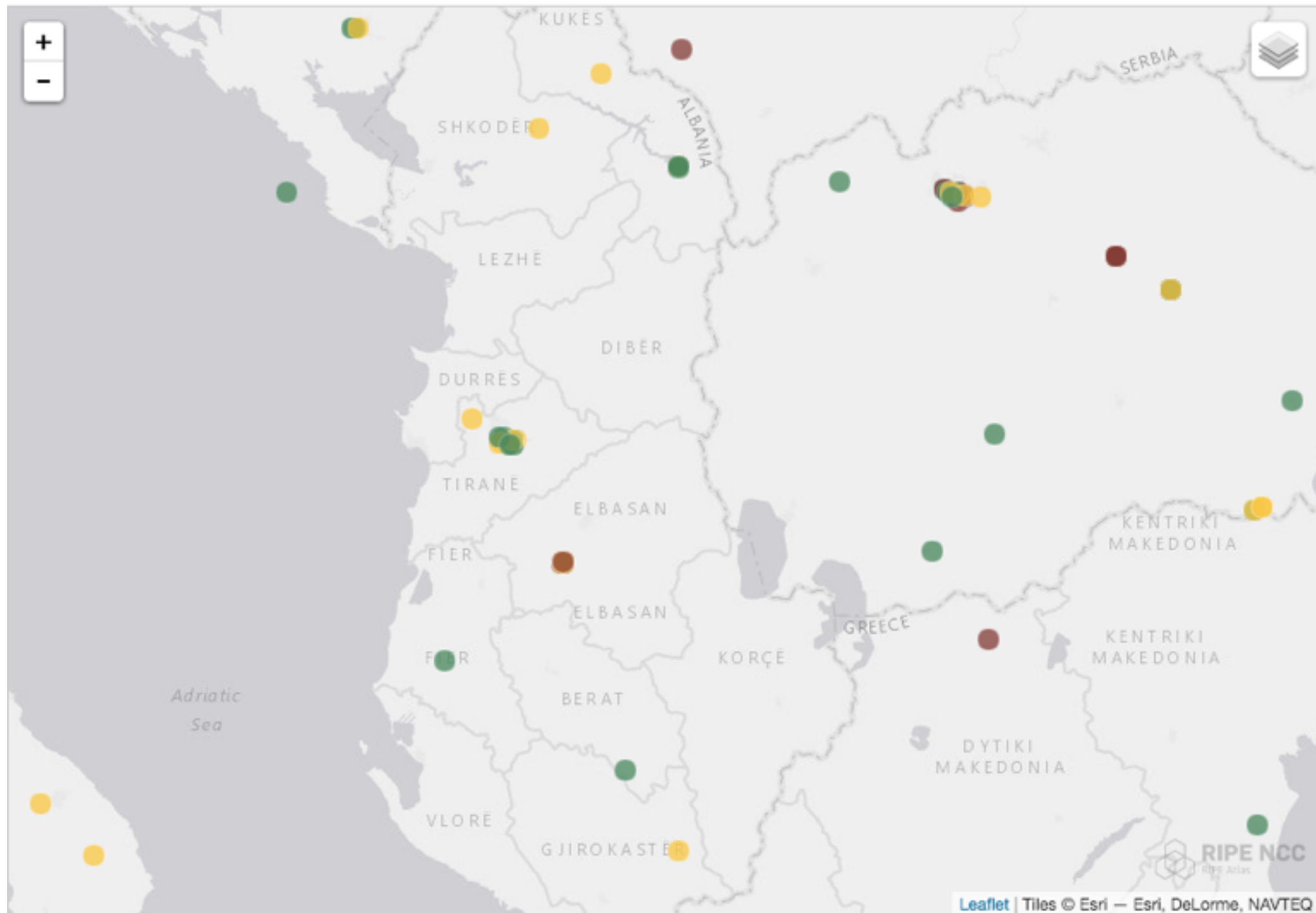


- 9,381 connected probes and 189 RIPE Atlas anchors
- Not far from our goal of 10,000 probes!

- Around 20 active probes

Policy Proposals Under Discussion



- **2015-04, “RIPE Resource Transfer Policies”**
 - Creates a single transfer policy document for all types of resources
- **2015-05, “Revision of last /8 criteria”**
 - Extra /22s can be requested every 18 months if no address space has been transferred before
- **2016-01, “Include Legacy Internet Resource Holders in the Abuse-C Policy”**
 - Requires legacy holders to set an abuse-contact in the RIPE Database

Resource Certification (RPKI) Update

- 3,500+ members have requested a certificate
- Members have created ROAs covering:
 - 2,886 unique ASNs
 - 14,446 IPv4 prefixes
 - 2,222 IPv6 prefixes
- All address space can now be covered
 - Including PI and legacy

RIPE NCC Academy



- Our new online learning platform
- Trainees can complete courses in their own time and be certified for their knowledge
- Complements existing courses and webinars already on offer

RIPE Academic Cooperation Initiative (RACI)



- Connects RIPE with the academic community
- Operators: learn about Internet research conducted by academics
- Academics: make connections and get feedback from the industry
- RACI presenters receive tickets, travel and accommodation at RIPE and regional meetings
- All applicants can publish their work on RIPE Labs: labs.ripe.net

At the GM in May

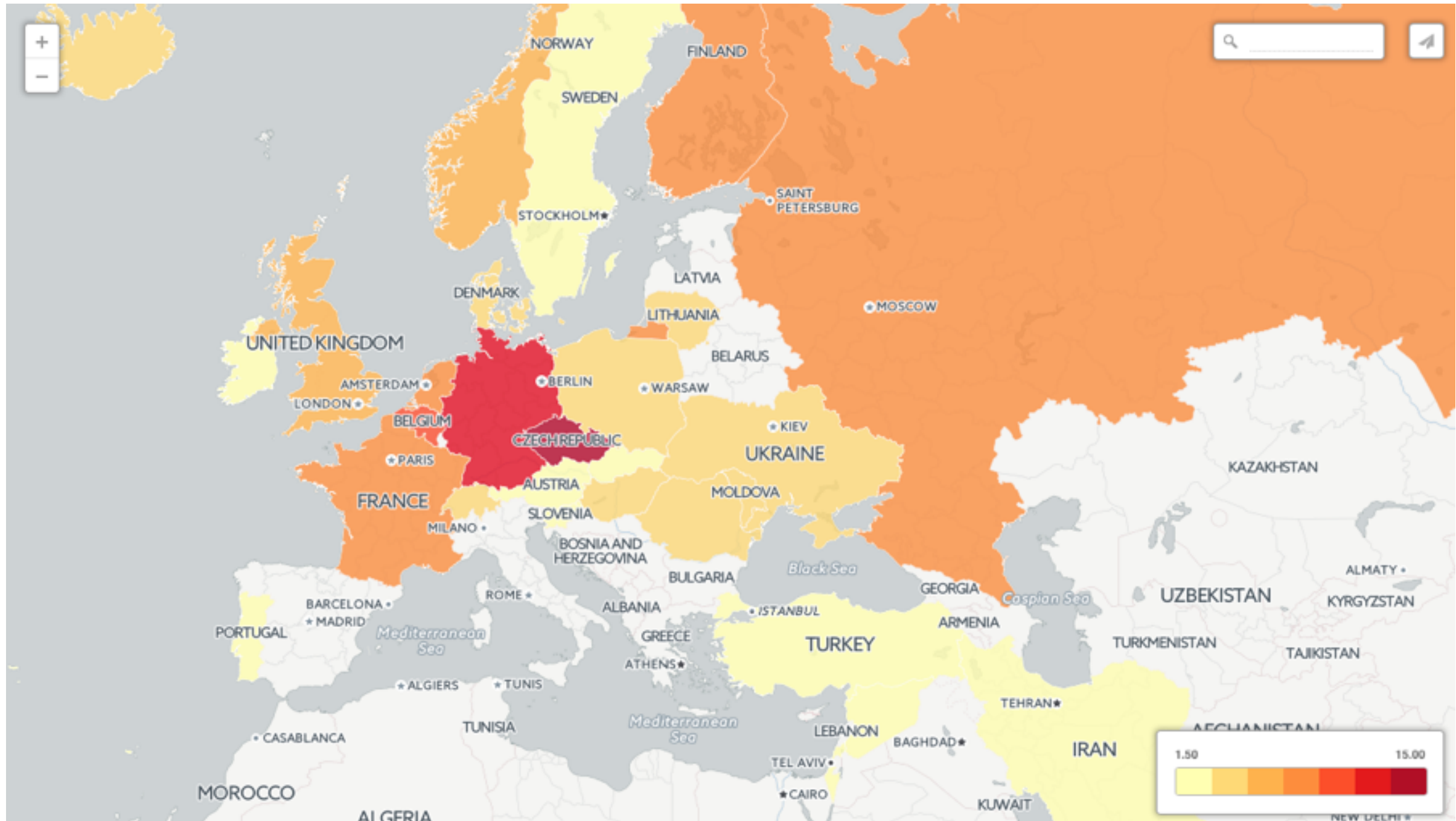


- RIPE NCC Executive Board election
